ISSUE:

Shall the Board of Trustees approve the bid award for solid waste and recycling disposal services?

FACTS:

1. Bids for solid waste and recycling disposal services were properly advertised in the Bozeman Daily Chronicle in May and June 2018.
2. Two bids were received within the timeframe established within the project specifications.
3. In compiling the bids, the lowest total bid for the specified three-year service period was deemed the low bidder. Republic Services' bid was \$194,886.42. The City of Bozeman's bid was \$171,955.14.

SUPERINTENDENT'S RECOMMENDATION:


It is recommended that the Board authorize administration to proceed with a bid award to the City of Bozeman for the District's solid waste disposal and recycling services for the period of July 1, 2018 through June 30, 2021 for a total cost of \$171,955.14.

DISCUSSION:

The low bidder also had the lower unit price for pick-up of miscellaneous additional waste (this was not a basis for bid award, however, since the miscellaneous waste volume is unknown – Year 1 \$6.50/cy, Year 2 \$6.50/cy, Year 3 \$6.50/cy).

ISSUE:

Shall the Board of Trustees authorize the administration to enter into an agreement to increase the GC/CM services contract by \$37,178,972 for Bid Package #3 - Construction Services Guaranteed Maximum Price for the High School #2 project with Langlas & Associates?

FACTS:

1. Langlas & Associates was selected by the Board to serve as the General Contractor/Contractor Manager (GC/CM) on November 14, 2016.
2. On May 2, 2017 a successful election authorized a \$125,000,000 bond levy for the design and construction of High School #2 and improvements to BHS.
3. Bid Package #1 was approved by the Board of Trustees on March 5, 2018 for a sum of \$14,251,316.
4. Bid Package #2 was approved by the Board of Trustees on April 23, 2018 for a sum of \$27,281,392.
5. Bid Package #3 was publicly advertised in May 2018 to solicit bids from pre-qualified, pre-selected and open ended subcontractors and vendors.
6. Bid Package #3 was publicly opened per statutory requirements on May 31, 2018.

SUPERINTENDENT'S RECOMMENDATION:

It is recommended that the Board authorize the administration to enter into an agreement to amend the GC/CM services contract for Bid Package #3 - Construction Services Guaranteed Maximum Price for the High School #2 project with Langlas & Associates to \$78,711,680 (Bid Package #1 - \$14,251,316 plus Bid Package #2 - \$27,281,392 plus Bid Package #3 - \$37,178,972).

OTHER ALTERNATIVES:

Suggest other contractors or contract modifications.

DISCUSSION:

This contract amendment establishes the Guaranteed Maximum Price (GMP) for the Bid Package #3 portion of the work associated with High School #2, along with finalizing the overall contractual agreement with Langlas and Associates. Bid Pack #3 work will consist of the following components for the final construction for the building: All interior finishes, interior windows, drywall and painting (interior and exterior), Plumbing, HVAC, electrical, and auditorium components. Some items that were bid out are FF&E components, but it was elected to receive bids in order to establish firm prices and schedules as they are integral to the overall project completion.

Also accounted for is the final portion of the Contractor's General Conditions, Profit, Bond, Gross Receipts Tax, and \$1,000,000 in project contingencies, along with the \$2,431,018 reimbursement from the City of Bozeman for the completion of the arterial roadway.

With the final bid package bids being received, we are now recommending accepting the following alternatives:

- Playing Field Permanent Fence
- Service Yard Fence Option 2
- Operable Windows in Classrooms
- Mechanical Penthouse - Region H
- Mechanical Penthouse - Region F/G
- Coffee/Cafe Kitchen Equipment and Casework
- Athletics Field Comfort Station
- Solid Surface Countertops Rm. B167 (ProStart Kitchen)
- Corner Guard Wall Protection
- Upgraded Plastic Laminate Countertops
- Upgraded Theatrical Lighting Controls & Equipment
- Upgraded Floor Finishes in Rooms A100 & A200

All alternates are included in the recommended Construction Services Guaranteed Maximum Price.

**GMP AMENDMENT TO THE STANDARD FORM OF CONTRACT
BETWEEN OWNER AND CONTRACTOR FOR GC/CM SERVICES**

THIS CONTRACT IS SUBJECT TO ARBITRATION PURSUANT TO THE UNIFORM ARBITRATION ACT, MCA TITLE 27, CHAPTER 5

This **AMENDMENT** to the CONTRACT entered into on December 22, 2016, is made as of:

Herein after identified as the "**CONTRACTOR**" or "**CM/GC**" and Bozeman Public Schools, acting through its Facilities Director, hereinafter identified as the "**OWNER**":

WITNESSETH that the Contractor and the Owner, for the consideration hereinafter named, Amend the Contract as follows:

ARTICLE 1 – SCOPE OF WORK

The Contractor shall perform, in accordance with this Amendment and the Contract:

- For All Work provided in the Documents identified as **New Bozeman High School, Bid Pack #3**, and 100% Construction Documents, dated May 0, 2018, inclusive of Project Manuals Volumes 4 & 5, and the Contractor's "Bid Package 3 Total Summary" received June 15, 2018 (except as modified herein).

ARTICLE 2 – CONTRACT SUM

The Owner shall pay the Contractor for performance of all Services, subject to additions and/or deductions by Amendment or Change Order or damages, the Contract Sum of:

- **Guaranteed Maximum Price (GMP) – Bid Package 3 GMP = \$37,178,972 thirty-seven Million, one hundred seventy-eight thousand and nine hundred and seventy-two DOLLARS** (See Appendix A for GMP Summary). Bid Package #1 Alternates number 2, 4, ,6, Bid Package #2 Alternates 1 and Bid Package #3 Alternates 1, 2, 3, 4, 5, 6, 7, 8, 9 & 11 are taken in this Amendment.

TIME OF COMPLETION

As time is of the essence in performance, coordination, and completion of all Services and Work contemplated under this Amendment. All Services and Work shall be performed and completed in accordance with the Request for Proposals, the Pre-Construction Services Conditions, and the General Conditions of the Contract for Construction and this Amendment as follows: (See Appendix B for Phase I Schedule).

- 2.1 The date of commencement of the Work shall be upon execution of this GMP Amendment by both parties which shall also serve as the Notice To Proceed;
- 2.2 All Work for Bid Package 1 and this GMP Amendment shall reach Substantial Completion by June 1, 2020 and all Work shall reach Final Acceptance no later than July 1, 2020;

ARTICLE 3 – PROGRESS PAYMENTS

The Owner shall make payments on account in accordance with the Contract Documents as follows: The Contractor shall be aware that the Owner has thirty-five (35) calendar days upon receipt in which to make approval and payment without being in violation of statute or being subject to the accrual of interest shall, or the need to make written notice or justification to deny payment in whole or in part. The Contractor shall, within seven (7) calendar days following receipt of payment from the Owner, make payment to subcontractor(s).

Construction Phase: Ninety-Five (97.5%) percent of the portion of the Contract Sum for this Amendment for labor, materials, and equipment incorporated in the Work and for materials suitably stored. Retention is payable upon Final Acceptance of the Work under this Amendment to the CM/GC within thirty-five (35) calendar days of CM/GC's Final Application for Payment.

ARTICLE 4 – FINAL PAYMENT

Final Payment, constituting the entire unpaid balance of the Contract Sum, shall be paid by the Owner to the Contractor when: 1) the Work is completed in accordance with the Contract Documents; 2) the Contract fully performed.

ARTICLE 5 – CONTRACT DOCUMENTS

The Contract Documents, together with this Contract, form the entire Contract and Agreement between the Contractor and Owner. The Contract Documents, which are totally and completely a part of this Contract as if attached here to or repeated herein, are enumerated in the General Conditions of the Contract for Construction inclusive of Wage Rates, Reports, and all other items bound with the Specifications and/or Project Manual(s). Addenda 1, 2, 3 were added to the contract documents during bidding time.

ARTICLE 6 – PREVAILING WAGE SCHEDULE

The Contractor and all subcontractors at any tier or level shall, as a minimum, pay the standard prevailing rate of wages schedule (including per diem, fringe benefits for health, welfare, and pension contributions and travel allowance) in effect and as applicable to the district in which the Work is being performed.

ARTICLE 7 – VENUE

In the event of any mediation, arbitration, or litigation concerning any matter or dispute arising out of or related to the Contract, venue shall be the Eighteenth Judicial District in and for the County of Gallatin, Montana. The Contract shall be interpreted and subject to the laws of the State of Montana.
